RESOLUTION 81-0716 LAKE ONTARIO STATE PARKWAY (LOSP)

WHEREAS, Governor Cuomo calls for a direct linkage between tourism, agriculture, and marketing the Upstate New York Region as a whole in order to foster economic development; and

WHEREAS, Orleans County relies upon safe and secure roads to move products to markets, produce food and fiber, and receive tourists; and

WHEREAS, the 15 mile-extension of the LOSP from Hamlin Beach State Park to Lakeside Beach State Park is in desperate need of repair; and

WHEREAS, 5.5 miles of this section of the LOSP has been labeled õRough Roadö by the Department of Transportation; and

WHEREAS, the current condition of the LOSP has a negative effect on the property taxes in the Town of Kendall and has significantly reduced commerce to areas of Orleans County; and,

WHEREAS, first responders in the Town of Kendall elect to take alternative routes because they deem the LOSP unsafe to use for emergency calls due to current road conditions; and,

WHEREAS, other parts of this federally-funded highway have recently been resurfaced, while the portion between Hamlin Beach State Park and Route 237, Kendall/Holley exit remains unattended to, now, therefore be it

RESOLVED, that the Kendall Town Board does hereby request that the Governor and the State Legislature immediately fund the repair and maintenance of this section of the LOSP so our residents and other tax payers can reap the same benefits as other residents who utilize New York State roadways throughout the state; and be it

FURTHER RESOLVED, that the Town Clerk hereby send this resolution to Governor Andrew M. Cuomo, Commissioner of DOT Matthew J. Driscoll, U.S. Congressman Chris Collins, Senator Kristen Gillibrand, Senator Charles Schumer, Senator Robert Ortt, Assemblyman Steve Hawley, Orleans County Chairman David Callard, Gayle Ashbery, Supervisor for the Town of Carlton, and Nadine Hanlon, Clerk of the Orleans County Legislature. Discussion: Councilman Newell questioned the timing of this resolution, given that the County is undertaking a feasibility study to look into alternative plans for the Parkway, rather than simple maintenance. Supervisor Cammarata said it is felt that unnecessary work has been completed on other sections of the LOSP, and this area should be demanding a fair share of funding for the section which directly affects the Town.

WHEREAS, this agreement is to be executed in furtherance of the provisions of Section 284 of the New York State Highway Law; and,

WHEREAS, the Town Board has determined that it is in the best interest of the Town to authorize the execution of the attached agreement, and,

WHEREAS, the execution of the agreement to spend town highway funds for repairs and improvements to Town of Kendall roads is hereby determined not to have a significant effect on the environment, so now,

Therefore, be it RESOLVED, that the Town Supervisor, Town Board members and Highway Superintendent be authorized to execute the attached Agreement to spend Town Highway Funds.

NEW BUSINESS

Solar Moratorium ó a prototype from Orleans County was distributed for review by Board, for its input regarding possible avenues of regulation of commercial solar farming. Supervisor Cammarata thought the distributed law was for a moratorium drafted by Attorney Meier, and said he would provide copies of such to each Board member for his/her consideration as to whether a moratorium would be appropriate for the Town of Kendall. Councilman Newell expressed the importance of researching issues associated with solar power, and specifically opt-out options and consequences.

Karl Driesel ó Monroe County Water Authority has informed Mr. Driesel that the easement to his property has been recorded. Mr. Driesel has some reservations about the wording of his agreement with MCWA to hook-up to the water line, regarding the issue of the Authorityøs ability to self-amend agreements. He wants the Board to be aware of the additional wording he has added to the agreement. It is added at the end of the last sentence in the first paragraph, and consists of: õexcept as the law and this applicant also agrees to comply with any current and future amendments to the Water Authorityøs rules and regulations, except as the law and/or arrangements between MCWA and the Town of Kendall otherwise, including the existing exemption provide an easement along Crandall Road.ö

With no further business brought forward, Councilwoman Szozda motioned for adjournment, seconded by Councilwoman Flow; meeting adjourned at 8:07 p.m.
