SUPERVISOR'S REMARKS

The purpose of this meeting is to present the maps, plans, and reports for the potential water districts 7 and 8, respectively, to the Town Board, to review the estimated costs to the affected property owners and debt incurrences associated with these potential water districts, and to set Public Hearings to solicit public input on these projects.

PUBLIC COMMENT

County Legislator DeRoller expressed optimism at the stage these projects have reached.

RESOLUTIONS

Attorney for the Town, Andrew Meier, explained the resolutions, said he would be responsible for mailing all affected parcel owners notices, and answered questions from the Board members.

Councilwoman Szozda made a motion to pass the following resolution, as written, with reading waived, seconded by Councilman Newell:

RESOLUTION 61-0516 Setting Water District 7 Public Hearing

WHEREAS, the Town Board of the Town of Kendall (herein called õTown Boardö and õTownö respectively), in the County of Orleans, New York, has heretofore caused the preparation of a general map, plan and report for the proposed construction of water improvements to provide a source of potable water in an area of the Town hereinafter described (the õWater Districtö), including land or rights in land, original furnishings, mains, pipes, appurtenances, equipment, machinery, apparatus, all within the unincorporated area of the Town outside of any villages, as more particularly described in Schedule õAö, annexed hereto, (the õBenefited Areaö), such improvements to involve the installation of approximately 8,000 linear feet of 10ö diameter PVC water main along a portion of Norway Road, (the õDistrict No. 7

Areaö) pursuant to Article 12-A of the Town Law, and which map, plan and report have been heretofore duly filed in the Office of the Town Clerk for public examination; and

WHEREAS, such Water District will benefit the entire Benefited Area, said area being hereby designated as the benefited area pursuant to the Town Law; and

WHEREAS, the Town Board and the Town will comply in every respect with all applicable federal, state and local laws and regulations regarding environmental matters, including compliance with the New York State Environmental Conservation Law prior to final authorization for this action; and

WHEREAS, the maximum amount proposed to be expended for the construction of such Water District is estimated to be \$860,000.00 and which is planned to be financed by the issuance of \$860,000.00 serial bonds offset by any funds received from the federal, state, county, and/or local grants including, but not limited to, grant and/or loan funds from USDA Rural Development, said balance of costs to be provided by the levy and collection of special assessments from the several lots and parcels of land within the Benefited Area which the Town Board shall determine to be especially benefited by said Water District No. 7, so much upon and from each as shall be in just proportion to the amount of benefit which the Water District No. 7 shall confer upon the same, to pay the principal of and interest on said bonds as the same shall become due and payable, and

WHEREAS, the annual cost of operation and maintenance of said Water District No. 7 shall be paid with a charge upon the Benefited Area which shall be levied and collected in the same manner and at the same time as other Town charges or by water rents or rates; and

WHEREAS, the estimated total first year costs to the typical property and typical one or two family home is the sum of One Thousand Four Hundred Nineteen and 84/100 (\$1,419.84) Dollars calculated by estimating (1) purchase of water meter, \$215.00 (2) installation of water service (50 lf x \$10.00 lf), \$500.00 (3) MCWA account initiation, \$15.00 (4) repayment of long term bonding, \$406.68, and (5) operation and maintenance, \$265.31, and (6) maintenance reserve \$17.85; and

WHEREAS, the cost of the district to a typical property and the cost of the district to a typical one or two family home (as defined in the Town Law) for the second year and beyond is now estimated to be the sum of Six Hundred Eighty-nine and 84/100 (\$689.84) Dollars per year, calculated as follows:

WHEREAS, the estimated total first year costs to the typical property and typical one or two family home is the sum of One Thousand Five Hundred Seventy-four and 84/100 (\$1,574.84) Dollars calculated by estimating (1) purchase of water meter, \$215.00 (2) installation of water service (50 lf x \$10.00 lf), \$500.00 (3) MCWA account initiation, \$15.00 (4) repayment of long term bonding, \$571.20 and (5) operation and maintenance, \$265.31, and (6) maintenance reserve \$8.33; and

WHEREAS, the cost of the district to a typical property and the cost of the district to a typical one or two family home (as defined in the Town Law) for the second year and beyond is now estimated to be the sum of Eight Hundred Forty-four and 84/100 (\$844.84) Dollars per year, calculated as follows:

Attorney Meier asked all voting members and the Clerk to stay and sign necessary documents.

Councilwoman Flow said Partyka Farms would like to donate part of any proceeds earned at the Homegrown Days dinner to the Town.

Councilman Martin entered the meeting, and the Attorney for the Town said a vote from Councilman Martin could be counted and recorded in the minutes of the meeting. Councilman Martin stated he records a vote of õayeö for each of the resolutions, 61-0516 and 62-0516. So recorded.

Councilwoman Szozda asked what has been done regarding the õDriesel situationö since the meeting in May.

Attorney Meier said all conversations have been positive, and MCWA has been cooperative. As these new water districts are completed, the Board will want to pay extra mind to the easement situation and be aware that an easement is not a deed, conveying limited, specified use, not ownership.

The Board is in agreement that it prefers the Town to hold those easements, rather than Monroe County Water Authority.

Supervisor Cammarata recognized and gave the floor to Ken DeRoller, Kendall resident and County Legislator. Mr. DeRoller suggested the Board prepare for questions at the Public Hearings regarding revisiting the Townøs agreement with the MCWA. Mr. DeRoller listed several things he feels MCWA has done wrong, including removing two vaults in 2013 which belonged to the Districts and filing easements without proper approval, saying MCWA õthinks theyøre dealing with a bunch of farmers hereö and suggested Kendall take a stand.

Attorney Meier agreed the agreement with MCWA is one-sided, but cautioned that it may not behoove the Town to force a standoff with the Water Authority at a time it is attempting water expansion projects.

Supervisor Cammarata expressed optimism that the issues can be resolved between the attorneys and the Board will closely monitor the process.

With no further business coming before the Board, Councilwoman Szozda requested the meeting be adjourned, seconded by Councilwoman Flow; all ayes. Meeting adjourned at 4:51 p.m.
