The current speed limit in front of the Kendall High School is 50 mph. Historically this has been proven to be dangerous for students, parents, faculty, community members and visitors traveling through the town. Other neighboring towns have much lower speed limits while driving in school zones.

Be it hereby resolved that the Kendall Town Board supports the reduction of speed in front of the Kendall Jr.-Sr. High School from 50 mph to 20 mph, during school hours.

Copies of this resolution should be sent to the NYS DOT, Senator Robert Ortt, Assemblyman Stephen Hawley, Orleans County Legislator Kenneth DeRoller, School Board President Nadine Hanlon, and Kendall School Superintendent Julie Christensen.

New York State Lake Ontario State Parkway alternative feasibility study ó a \$55,000 grant has been given to the Genesee Transportation Council to perform a study of possible repurposing of the Parkway. Representatives from NYS DOT, the Genesee Council, NYS Parks, Carlton, Kendall, and Orleans County Planning make up a select committee. A consultant has been chosen to head the study. A contract will be made, and the committee will be expanded to form a steering committee. Community involvement will be requested and considered heavily.
