## PUBLIC HEARING FOR APPROVAL FOR A SPECIAL USE PERMIT - TAX ID #33.4-1-18

Chairman Kludt opened the public hearing at 7:05 p.m. He read the public notice.

Notice is hereby given that a public hearing will be held by the Planning Board of the Town of Kendall on Tuesday, November 22, 2016 at 7:00 p.m. at the Kendall Town Hall, 1873 Kendall Rd. to consider the application of Ryszard Jurzysta, 17284 Sand Rd. Tax ID #33.4-1-18. Applicant seeks approval for a special use permit to operate a home business (saw mill) in the Residential Hamlet District (RH). All persons wishing to speak will be heard at this time. Application is on file in the Town Clerk's office.

Chairman Kludt gave the applicant a chance to speak and explain to the board why he is seeking approval for a special use permit. The applicant Mr. Jurzysta explained to the board he would like to open a small electric band saw mill to produce repair boards for apple and cabbage crates. The mill would be located at a preexisting barn on his property. Mr. Jurzysta will not have employess. The hours of operation woud be 9 a.m. to 5 p.m. Sunday - Saturday. He spoke with Warren Kruger from the Town of Kendall Highway Department about putting in a forty foot (40') driveway coming off of Sand Road to accommodate truck traffic for drop off and pick up purposes. Finished products will be stored inside the mill along with any equipment. If approved he would like to have the mill up and running within one to two years.

Chairman Kludt closed the public hearing at 7:22 p.m.

Chairman Kludt asked for a motion to approve the special use permit. John Hughes motioned to approve the special use permit to operated a home business (saw mill) at 17284 Sand Road, Kendall, NY. Seconded by Jeff Conte. All in favor. Chairman Kludt asked for a motion to approve the special use permit with the condition of applicant combining his two tax parcels into one. John Hughes motioned to approve. Seconded by Jeff Conte. All in favor.
