Kenmor Road problem by

Kenmor Road problem house – "Serve-Pro", the bank's maintenance company, has been contacted again. Condemnation and demolition will be the likely recommendation, at which time the Town Board will become responsible for disposition. The bank is hesitating to take official ownership and make its recommendation. If it accepts ownership, it has thirty days to make a decision. The owner of record cannot be found.

Cottages at Troutberg -1 new house being built; new principal interest is planting trees and adding signage. A Town Board liaison is necessary to co-ordinate emergency services, as soon as possible, who can support site plan issues. (Councilman Newell volunteered to be this liaison.)

Councilman Newell asked about a problem property on Norway Heights. Work is being done, and the owner has agreed to complete the demolition, and has lowered his asking price for the property. Councilman Newell expressed concern for safety.

WHEREAS, the Town Board has determined that it is in the best interest of the Town to authorize the execution of the attached agreement, and,

WHEREAS, the execution of the agreement to spend town highway funds for repairs and improvements to Town of Kendall roads is hereby determined not to have a significant effect on the environment, so now,

Therefore, be it RESOLVED, that the Town Supervisor, Town Board members and Highway Superintendent be authorized to execute the attached Agreement to spend Town Highway Funds.

RESOLVED, that the Plan is hereby amended to add vision as an eligible expense in addition to deductibles and prescriptions. And be it further

RESOLVED, that the proper officers of the corporation are authorized to execute the amended and restated Plan, pay benefits as provided therein, and to do every other act or thing necessary or proper to meet and comply with the obligations as therein provided and to carry these resolutions into full force and effect, and to direct counsel to take such action as may be necessary to satisfy any applicable requirements of law.
