CORRESPONDENCE

MVP Health Care, May 14, 2009 – regarding a retroactive increase in premiums

A discussion of the potential impacts on the town's medical plan, the town employees, the "cafeteria plan", and the budget, was led by Councilman Gaesser.

Orleans County Board of Ethics – invitation to meet the members of the Board of Ethics

Supervisor Gillman introduced Richard Ertel from Amato, Fox and Co., who presented an overview of the audit results for the Town of Kendall for the year ended December 31, 2008. Mr. Ertel presented copies of the audit report to the Board and Clerk, with copies of the audit of the Town of Kendall Municipal Court.

PUBLIC PARTICIPATION

Stephen Seaman, Carr Road – expressed concern that Eagle Creek Marina not making its repayments will adversely affect next year's audit.

Supervisor Gillman suggested that be "addressed later".

Mr. Seaman asked if is true that the Marina is not current in paying its bill.

Supervisor Gillman stated that he will not answer that question, because it relates to a "personal situation".

Iberdrola Renewables – wind energy

Supervisor Gillman stated that there have been two meetings with this company regarding potential sites for windmills in Kendall.

Councilman Joseph said that none of the council members were aware of the meetings, and that he is disappointed in the lack of communication, particularly about such a potentially volatile subject. He expressed his commitment to open communication.

Councilman Schuth said the Planning Board acts as adviser, not decision maker for these issues. The Town Board needs to review all proposals. The current local law would need modification to allow any large numbers of wind towers.

Councilman Joseph requested that any future meetings to be open to the public and have minutes taken.

With there being no further business coming before the board, Councilman Schuth motioned for adjournment, seconded by Councilman Gaesser; all ayes. Meeting adjourned at 8:25 p.m.
