PUBLIC COMMENT

Mr. Lofthouse – asked if the Wegman Group has accepted the P.I.L.O.T. program. Supervisor Cammarata deferred to Legislator DeRoller, who said as of now, no. Mr. Lofthouse suggested the information of the process involved be shared with the public.

Mr. Lofthouse complained about the misspelling of KENMOR Road, as KENMORE on the road signs. It needs to be corrected, as it leads to confusion. Clerk Richardson said PETERSMITH Road is also incorrect on the signs, and COUNTYLINE may also be. Attorney Meier said that can be changed through the Highway Superintendent.

RESOLUTION 75-0714 ADOPTION OF LOCAL LAW 1 OF 2014: A LOCAL LAW AMENDING THE ZONING MAP OF THE TOWN OF KENDALL

Whereas the Kendall Town Board has considered the proposed revisions to the Town of Kendall Zoning Map concerning changing four parcels to Light Industrial, as reviewed and recommended by the Kendall Planning Board, and as submitted to and accepted by the Orleans County Planning Board, and

Whereas, the Town Board conducted a public hearing to consider adoption of proposed Local Law #1 of the year 2014 on July 15, 2014 in the Kendall Town Hall, 1873 Kendall Road, Kendall, NY 14476, at which time all persons wishing to be heard in favor or in opposition thereto were heard,

Now, therefore be it resolved that Local Law 1 of 2014 of the Town of Kendall, Orleans County, New York, being a local law entitled "A Local Law Amending the Zoning Map of the Town of Kendall" be adopted, as attached; and

Further, be it resolved, that upon passage of this resolution, the Kendall Town Clerk is authorized to submit this Local Law to the New York State Department of State for filing, and to incorporate these changes into the Town of Kendall Zoning Ordinance for enforcement.

Supervisor Cammarata called for a vote, resulting in all ayes, and declared the motion carried.

Councilwoman Szozda made the following motion, seconded by Councilman Newell:

RESOLUTION 76-0714 APPOINTING SHAD SPEER TO THE ZONING BOARD OF APPEALS

Whereas the Town Board considered and chose said appointed member to the Zoning Board of Appeals and still does desire to appoint said candidate, so

Now, therefore, be it RESOLVED to appoint Shad Speer, 16203 Carr Road, Kendall, NY to the position of member of the Zoning Board of Appeals with this term of office to begin immediately and to expire on December 31, 2017.

Councilman Newell made the following motion, seconded by Councilwoman Szozda:

RESOLUTION 77-0714 ACCEPTING THE RESIGNATION OF PLANNING BOARD CHAIRMAN WENZEL

Whereas a letter of resignation from Raymond Wenzel of his duties as Town of Kendall Planning Board Chairman and as Orleans County Planning Board representative for the Town of Kendall has been received by the Town Clerk, so it is

RESOLVED, that the Kendall Town Board, with much regret and appreciation for a job well-done, does accept Mr. Wenzel's resignation, effective on July 25, 2014.

Councilwoman Szozda made the following motion, seconded by Councilman Newell:

RESOLUTION 78-0714 APPOINTING ANDREW KLUDT AS PLANNING BOARD CHAIR AND RECOMMENDING HIM AS ORLEANS COUNTY PLANNING BOARD REPRESENTATIVE

Whereas the resignation of Mr. Wenzel leaves a vacancy on the Planning Board, and a vacancy in the Chairmanship of that Board, and in the position of representative for Kendall to the Orleans County Planning Board, and

Whereas Planning Board member Andrew Kludt has been contacted and has agreed to take chairmanship of the Kendall Planning Board; therefore be it

RESOLVED, to appoint Andrew Kludt as Chairman of the Town of Kendall Planning Board, effective on August 1st, 2014, with such appointment expiring on December 31, 2017; and be it further

RESOLVED, to recommend to the Orleans County Legislature the appointment of Andrew Kludt as the representative from the Town of Kendall to the Orleans County Planning Board.

Supervisor Cammarata called for a vote, resulting in all ayes, and declared the motion carried.

Councilman Newell made the following motion, seconded by Councilwoman Szozda:

RESOLUTION 79-0714 ADVERTISE VACANCY ON THE KENDALL PLANNING BOARD

Whereas the Town of Kendall Planning Board now has a vacancy, so be it

Whereas a letter of resignation from Russell Levett of his duties as Kendall Town Councilman has been received by the Town Clerk, so be it

RESOLVED, that the Kendall Town Board does regretfully accept Mr. Levett's resignation, effective immediately.

Supervisor Cammarata called for a vote, resulting in all ayes, and declared the motion carried.

Councilman Newell made the following motion, seconded by Councilwoman Szozda:

RESOLUTION 81 -0714 AUTHORIZING THE SUPERVISOR TO ENTER INTO AN AGREEMENT TO PROVIDE A BAND FOR THE STREET DANCE CELEBRATION

Whereas, there is an event including a street dance planned for August 16, 2014, therefore

Be it resolved to authorize Supervisor Cammarata to enter into an agreement with Country Class, a local band, to provide music for said street dance, from 7:00 p.m. to 11:00 p.m., at a cost not to exceed \$650.00, and further resolved to authorize that payment to be made on that date.

Supervisor Cammarata called for a vote, resulting in all ayes, and declared the motion carried.

Councilwoman Szozda made the following motion, seconded by Councilman Newell:

RESOLUTION 82-0714 WAIVER OF OPEN CONTAINER LAW

BE IT RESOLVED that the Town of Kendall Open Container Ordinance be waived during the 2014 Town of Kendall Street Dance as follows:

Saturday, August 16 from 6:00 noon to 12:00 midnight

And, that this waiver shall cover a square in the area 1/4 mile South and 1/4 mile East commencing at the intersection of Kenmor Road and Kendall Road, and

Further, such waiver is in effect only on the specified date and time set for herein and only in the geographical area described herein.

Supervisor Cammarata called for a vote, resulting in all ayes, and declared the motion carried.

Councilman Newell made the following motion, seconded by Councilwoman Szozda:

RESOLUTION 83-0714 (Submitted by Councilman Bart Joseph), TO INTRODUCE PROPOSED LOCAL LAW 2 of 2014 - INCREASING THE MAXIMUM INCOME ELIGIBILTY LEVEL FOR SENIOR CITIZEN TAX EXEMPTION UNDER SECTION 467 of the REAL PROPERTY TAX LAW

WHEREAS the Primary Concern of the Town Board is to be financially responsible and provide equitable relief for our Senior Citizens, and

WHEREAS the Senior Citizen Tax Exemption has not been increased since 1997, and

WHEREAS the Town Board of Kendall is authorized by Section 467 of the Real Property Tax Law of the State of New York to define the income eligibility levels for determining qualification for the partial exemption from real property taxes for persons sixty-five (65) years of age and older who meet the statutory requirements, and the Kendall Town Board desires to redefine those levels according to the following schedule:

so now therefore,

Be it RESOLVED, that the Kendall Town Board does introduce Local Law 2 of 2014, to be in an official format at least ten days prior to the public hearing, for consideration by the Town Board and to allow for public input, and further,

That the Town Clerk is authorized and directed to place a Legal Notice for a Public Hearing to consider adoption of this law, to be held on August 19, 2014 at 7:00 p.m., and to make the text of this local law available at the Town Clerk's Office for public inspection.

Discussion:

Neither Councilman Newell nor Councilwoman Szozda had seen this proposal, and wished to have more information.

Supervisor Cammarata said this change was suggested by the Assessor. It has been instituted through most of the county. The situation is outdated. This has been presented at the O. C. Supervisors' and Legislators' Meeting. Councilwoman Szozda asked for the current income limits for comparison, which were provided and reviewed.

Supervisor Cammarata called for a vote, resulting in all ayes, and declared the motion carried.
