RESOLUTION 84-0812 Resolution Declaring The Town Board of the Town of Kendall's Intent To Act as the Lead Agency Pursuant to the New York State Environmental Quality Review Act ("SEQRA")

WHEREAS, The Wegman Group has submitted an application to the Town of Kendall (the "Town") to develop a three season cottage resort located on approximately 125 acres of land in the Town (the "Project" or "The Cottages at Troutburg"); and

WHEREAS, the Town Board of the Town of Kendall (the "Town Board") must comply with SEQRA and its implementing regulations at 6 N.Y.C.R.R. Part 617 in the review of the Project; and

WHEREAS, the Town Board is an involved agency pursuant to SEQRA; and

WHEREAS, the Project is a "Type I" action under SEQRA, requiring a coordinated review; and

WHEREAS, the Town Board intends to serve as the Lead Agency for the coordinated SEQRA review of the Project; and

NOW, THEREFORE, BE IT RESOLVED by the Town Board of the Town of Kendall that:

- 1. The Project is hereby determined to be a Type I action under SEQRA.
- 2. The Town Board hereby declares its intent to act as Lead Agency, pursuant to SEQRA, for the purpose of conducting the environmental review of the Project.
- 3. The Town Board hereby directs the Town's special counsel to send the attached Notice of Intent to Act as Lead Agency to the following involved/interested agencies: (a) New York State Department of Environmental Conservation; (b) New York State Department of Health; (c) New York State Department of Transportation; (d) New York State Department of State, Office of Coastal Resource Management; (e) U.S. Army Corps of Engineers; (f) Orleans County Planning Department; (g) Orleans County Economic Development Agency; and (h)Town of Kendall Planning Board.
- 4. This Resolution shall be effective immediately.

Discussion: The plan approval process and rezoning SEQR processes will be simultaneous.
