PUBLIC PARTICIPATION

John Ulmen, Lakeshore Road – questioned the Democratic majority's recent decisions to acquire Banner Beach Road, and to complete a private resident's water line hookup. Mr. Ulmen asked if water could be run down Lakeshore Road. The residents there have poor quality and poor quantity of water. Mr. Ulmen expressed that priority for spending should be to first make water available to as many residents as possible.

Councilman Joseph responded that the decisions were based partly on safety issues. Mr. Joseph gave an explanation of the process required to establish water districts. Councilman Gaesser spoke about the new grants available for establishing new districts and installing water.

Donald Pritchard, Norway Road – said MCWA will not service non-ductile iron pipes without extra charge; the Town Board of Kendall generally applies for grant money annually, but last time the town was denied. Each neighborhood is evaluated for the grants based upon financial need and population density.

Rod Hughson, Carton Road – expressed concern that if the formula is based on density, his neighborhood, with only two Kendall homes, will have a slim chance of getting public water. Councilman Joseph responded, "not necessarily." The Town of Murray could extend service from their end, if expanded.

RESOLUTIONS

Councilman Gaesser made the following motion, seconded by Councilman Schuth:

RESOLUTION 78-909 NYS SNOW AND ICE AGREEMENT FOR 2010/2011

BE IT RESOLVED That the Town Board of the Town of Kendall hereby authorizes the Supervisor to sign the agreement to extend the "Agreement to Extend Conventional Municipal Snow and Ice Agreement for the 2010/2011 contract year, with NYSDOT.

Supervisor Gillman called for a vote, which resulted in all ayes; motion carried.

Councilman Schuth made the following motion, seconded by Councilman Gaesser:

RESOLUTION 79-909 SCHEDULING PUBLIC HEARINGS FOR ZONING CHANGES

Whereas the Kendall Town Board has received from DMD Machine a request for property zoning changes of 5.1 acres of property identified as Parcel #32.2-1-28 from Residential/Hamlet (RH) District and Residential/Agricultural (RA) District to Light Industrial (IL) District and now therefore, to allow for public input,

The Town Clerk is authorized to place a Legal Notice of a Public Hearing for public input to the Kendall Town Board for adoption of this proposed change in zoning. The Public Hearing is set for October 8, 2009 at 7:30 p.m. at the Kendall Town Hall, 1873 Kendall Road, Kendall, New York. The Town Clerk is to make the text of this proposed zoning change available at the Town Clerk's office for public inspection.

Supervisor Gillman called for a vote, which resulted in all ayes; motion carried.

Councilman Gaesser made the following motion, seconded by Councilwoman Szozda:

RESOLUTION 80-909 TRANSFERRING FUNDS

It is hereby resolved to authorize the bookkeeper to make the following budget transfers:

Transfer \$3,000.00 From Special Items, Contingent Account - A 1990.4 to Law, Contractual A 1420.4

Discussion: Councilman Schuth asked Attorney Leone if this would be enough to finish the year's legal expenses. Attorney Leone responded that would depend on the Board's decisions. Councilman Joseph stated that any more spent will be carefully considered. Councilman Gaesser added that this amount is to cover projected municipal representation only; no special projects outside the cap. The Board is suspending "outside the cap" work.

Supervisor Gillman called for a vote, which resulted in all ayes; motion carried. Councilman Joseph made the following motion, seconded by Councilwoman Szozda:

RESOLUTION 81-909 TO AMEND THE 2009 BUDGET

It is hereby resolved to authorize the bookkeeper to make the following budget transfers: Increase A 9901.9 Transfers to Other Funds seven thousand seven hundred dollars (\$7,700.00) Increase DA 5031 Interfund Transfer seven thousand seven hundred dollars (\$7,700.00) Increase DA 9060.8 Hospital & Medical Insurance seven thousand seven hundred dollars (\$7,700.00)

Discussion: Councilman Schuth said it appeared that the fund for highway medical insurance payments was over budget before the pre-pay went out. Councilman Joseph confirmed this was the case. Payment was made to avoid late penalties or lapse in coverage. A breakdown of the calculation was given. Councilman Schuth expressed frustration at the lack of up to the minute information provided by the accounting system.

Supervisor Gillman called for a vote, which resulted in all ayes; motion carried.

Councilman Schuth moved the Payment of Claims be approved, as listed, seconded by Councilwoman Szozda; all ayes.
