#### PUBLIC COMMENT

Water Expansion - already discussed

Codification – on-going

Natural gas line expansion – feasibility study begun with NYSEC

Beechwood Cemetery Chapel repair – already discussed

Ad hoc committee for Healthcare Consortium – next mtg. Oct 29<sup>th</sup> in Lyndonville

Cemetery rates – Councilman Joseph provided a spreadsheet. Grave and interment prices are lower in Kendall than in many of the surrounding cemeteries. A modest increase is proposed, to enable proper upkeep of the graveyards. The next steps are to revisit a legal release of the cemetery trust funds, and a separate escrow account being started to fund perpetual care. The history and family ties within the cemeteries deserve our respect and care and require funding. Councilman Joseph seeks public comment and suggestions.

County Legislator DeRoller said he used to work for the Town of Kendall, and did mowing at the cemeteries. He suggested the Board reconsider the fenced in areas, as they require extra time for mowing and use of a hand mower. He said, "I know it is history and so forth and so on, but when you are looking at dollars, it's a....and the older plots, too. They are way back in time, at Beechwood Cemetery, dating to the 1800's. I've never seen any family there or flowers left on any of those graves, so it's something to consider."

Supervisor Cammarata thanked Mr. DeRoller and said that the Board is looking for suggestions. Councilman Joseph said they would never consider NOT maintaining any section of the cemeteries, regardless of any family involvement.

With no further business being brought forward, Councilwoman Szozda motioned for adjournment, seconded by Councilman Joseph; all ayes; meeting adjourned at 8:08 p.m.
