#### **CODE ENFORCEMENT OFFICER:**

CEO Hennekey passed out a map to the board members regarding Tax Map #11.-1.7.1. This house sits way back off the road and the right-of-way actually goes through this property. The property owner would like to sell a portion of the property (120' X 150') to the neighbor that lives in the first cottage on Norway Heights on the Lakeshore side bordering on Norway Heights and Norway Road. He believes that this size lot is considered a build-able lot but is questionable because he will not have the 140' that is required for Lake Front. Are we creating a flag lot because his driveway is off of Norway Road or are we considering it not a flag lot because the property owner has so much road frontage from the other road? CEO Hennekey will talk with the Town Assessor Gene Massey regarding this property.

Karl Drisel came in to speak with CEO Hennekey, he told Paul they are still surveying his property. Karl told Paul there seems to be some dispute, nobody can find out when the Town of Kendall actually took ownership of east west portion of Crandall Avenue. It used to be a

dead-end and now it is not. They cannot find anything in the deed or abstract that says the Town of Kendall owns that portion. According to the abstract he owns the east west portion of Crandall Avenue. Karl is waiting for this issue to get straightened out so he can move forward.
