Quiet month. Hot and dry weather making consumption up. - Clerk counted quarters - \$473 in bulk consumption

Monroe County Water Authority has been testing master meters. Repaired fire hydrant in firemen's field after carnival due to minor mishap with loader. List of all properties on meters to Kendall Assessor's office for maintenance fee. New piece of main on Roosevelt Highway in Hamlin just activated last week.

Warren Kruger - Highway Superintendent

- Drainage on Ken Mor Road east of Kendall Road completed No routine rain to test it nor helping grass grow.
- Patching areas of the roads with chips seal.
- Sidewalk Section on Kendall Road (near Sprague's) supplies will be delivered within 2 weeks.
- Worked at Lake worked on some of the easements cleaned out parkway drains.
- David Lange State DOT resident engineer moving him from Batavia to Rochester. Now in Batavia is a residency manager person with less authority.
- Highway Association negotiated with State raising highway equipment reimbursement rates by 4.7% as a result of fuel rate increases.
- Steve Jones, Highway Superintendent from Carlton and Warren Kruger made presentation to jointly purchase a used Screener/Stacker combination. This will allow the two towns to recycle certain materials back into reusable materials to cut costs. Could save up to \$10,000 per year with recycling materials. Carlton now is saving about \$13,000 on an upcoming project. Carlton Board approved \$6500. for the purchase of the screen. Town of Kendall to contribute \$5500 for the stacker. Neither of the units are "spring chickens" but technology has not changed much. Can be used for screening own top soil, recycling road materials, and mixing salt and place it in salt storage facility. Typically rented equipment for these duties. Ownership will be on the stand alone units for each town. Supervisor Becker asked that each of the Highway Superintendents place in writing how the repair costs, usage etc will be handled between both towns. Attorney Heath suggested that a Municipal Cooperation Agreement be developed.
- Starting drainage on Monday on the Crandall Ave block in response to the neighbors needs.
- Intermogul Representative will be meeting with Warren regarding the Drainage Grant Information for application.
- Councilman Weisenburg asked if a written agreement was made with the Freitag's regarding sidewalk project Warren indicated that we are in the right of way. Their concern was just with the tree. Leach field is not a problem.

Attorney Heath extensively reviewed the Loan and Security Agreement between the Town of Kendall and Jim Freemesser, Inc. dba Eagle Creek Marina for the Small Cities Community Development Block Grant Program. This agreement was established by Stu Brown's Office. Some major points of discussion included and should be considered for agreement:

Ask for general assignment of rents, request personal guarantees from Jim Freemesser and Peggy Freemesser, Project description needs to be compared with the Planning Board conditions, mortgage subordinate to the mortgage held by Lyons National Bank, security interests in fixtures, equipment, inventory, supplies, accounts receivable, chattels, general and tangible an all other properties located on the property and be sure that Jim and Peggy have Keyman Life Insurance.

Loan and Security Agreement was reviewed page by page and appropriate changes were made. Modifications will be discussed with Stu Brown and Final Document to be circulated. A major issue is that with other Loan from Lyons National Bank we will forever be in second position should defaults occur.
