**SUPERVISOR’S REMARKS**

Supervisor Cammarata welcomed Justice Gaudio and Councilman Martin, and thanked everyone for attending. Transformation best describes the past year. There have been changes in personnel on the Town Board, Planning Board, Zoning Board, Clerk’s Office, and Board of Assessment Review, and Supervisor Cammarata thanked those who have filled the vacancies, to aid our community. Supervisor Cammarata expressed that he recognizes change is a constant, and he will try to anticipate, rather than react to, changes. The objectives this year include continuing the effort for new water district development, a feasibility study for expansion of natural gas, cemetery rate changes, and resolving the Hamlin-Kendall Water District dissolution issues. These will be the main projects for 2015. Supervisor Cammarata will engage Fiscal Advisors to lower a debt obligation, restore a cemetery committee, and create an innovation committee of community members, “initiating different views, different concepts and desires, presented on an as needed basis, to provide us marketplace intelligence and/or perspectives on our town.” Councilman Martin can be a liaison to such committee.

**PUBLIC COMMENT**

Al Lofthouse – asked what the duties of the Fair Housing Officer are.  
Supervisor Cammarata said he has not been asked to act in that capacity since his term began.  
Attorney Meier stated the position is “a creature of state law”, and pertains mainly to complaints of discrimination in housing.

Be it resolved that the following Salary Schedule and Work Agreement for the Highway Department be adopted for the year 2015 as submitted by the Highway Superintendent, Warren Kruger:

**TOWN OF KENDALL HIGHWAY DEPARTMENT  
SALARY SCHEDULE AND WORK AGREEMENT FOR 2015**

**The Town of Kendall Highway Department Employees will be paid on the following schedule for 2015;**

Full Time Motor Equipment Operators (MEO) - from Federal minimum wage up to \$19.36 per hour

Part Time Motor Equipment Operators (MEO-PT) - from Federal minimum wage up to \$12.56 per hour

Full & Part Time Laborer- from Federal minimum wage up to \$10.90 per hour

Employees are to be paid biweekly for an 80 hour pay period. Time and one half (1-1/2) wages will be paid for overtime beyond forty (40) hours worked in each week.

Employees will be provided work clothes up to \$300.00 per year through a uniform service or reimbursement for employee purchases with documented receipts. By law, the Town does not reimburse for sales tax paid.

Following completion of a two (2) month probation period, sick time benefits will be paid to full-time employees as follows:

1st year of employment	up to five (5) days paid
2nd year of employment	up to ten (10) days paid
3 <sup>rd</sup> year of employment	up to fifteen (15) days paid
4th year of employment	up to twenty (20) days paid
5 <sup>th</sup> year of employment	up to twenty-five (25) days paid

Beyond five (5) years: May accumulate one (1) additional day per month. Worked up to a maximum of one hundred eighty (180) days paid.

A certificate from the employee's physician will be required after being sick for five (5) consecutive days for benefits to be paid.

Sick pay accumulation will NOT be paid out at retirement or termination. Vacation time benefits will be paid to full time employees as follows and may NOT be carried over or accumulated into the next year.

The Highway Superintendent may deny specific dates for vacation because of workload requirements.

First year of employment may accumulate one (1) paid day of vacation for each month worked after completing a two (2) month probation period, (maximum 10 days), second through tenth year ten (10) days paid vacation. After ten years fifteen (15) days paid vacation.

Holidays will be paid for Full Time employees as follows:

New Year's Day, Martin Luther King's Birthday, Good Friday, Memorial Day, Fourth of July, Labor Day, Election Day, Veteran's Day, Thanksgiving Day, and Christmas Day. Saturday holidays will be observed on the Friday preceding the holiday, and Sunday holidays will be observed on the Monday following the holiday.
