RESOLUTION 53-0215 MCWA EASEMENT - <u>APPROVAL OF AQCUSITION OF AN</u> EASEMENT BY THE MONROE COUNTY WATER AUTHORITY PURSUANT TO §1096(6-a) OF NEW YORK'S PUBLIC AUTHORITIES LAW

WHEREAS, The Monroe County Water Authority ("Authority") is responsible for the future replacement of the existing water main along Woodchuck Alley, in the town of Kendall; and

WHEREAS, the acquisition of one (1) easement is necessary for the construction, installation, operation, and maintenance of a replacement water main; and

WHEREAS, the approximately $[167' \times 15']$ easement necessary for the replacement water main is located along the frontage of 16682 Woodchuck Alley (Tax Acct. No. 21.-1-42), which is owned by Benjamin Poprawski; and

WHEREAS, the acquisition is necessary to allow for the completion of the construction, installation, operation, and maintenance of the replacement water main which will allow the Water Authority to continue to provide potable water supply and fire protection to the area; and

WHEREAS, §1096(6-a) of New York's Public Authorities Law requires the Water Authority to obtain the prior approval of the above-referenced acquisition by the Town Board.

NOW, THEREFORE, let it be

RESOLVED, that the Town hereby approves of the Water Authority's acquisition of Woodchuck Alley easement in accordance with \$1096(6-a) of the New York Public Authorities Law and be it further

RESOLVED that a copy of this resolution be provided to the Monroe County Water Authority.

DISCUSSION: Highway Superintendent Kruger questioned the purpose of this easement.

Attorney Meier responded that this is a private easement between a resident and MCWA, but under Public Authorities Law, the municipality must also consent to the easement.

Highway Supt. Kruger asked if the purpose is to run a water line to this house.

No one on the Board knew.

Superintendent Kruger advised the Board to have an understanding of the intent of this resolution before passing it.

Councilman Newell interpreted the resolution as MCWA's attempt to have paperwork in place in the anticipation of future needs for access.

Superintendent Kruger stated all easements were in place at the installation phase of that water line, and would still be in place.

Attorney Meier said his understanding is that MCWA requires this easement to perform maintenance and/or repairs.

Supervisor Cammarata motioned to postpone voting on this until more information is provided by MCWA. No second to the motion, but the resolution was declared tabled and no vote was taken.

Water Expansion - awaiting recommendations from LaBella

Codification – awaiting revised pages and CD's. There will not be a sufficient number of books for all who should have one, and the costs are quite varied depending on what is ordered. Online maintenance is available, but expensive. Councilman Newell will seek input from Code Enforcement Officer Hennekey, and the Planning Board and Zoning Board of Appeals Chairmen.

- Natural gas line expansion estimates are cost prohibitive thus far, but did not address expansion to lakefront, where population density is higher. More information is anticipated.
- Town's electric supplier will stay with National Grid as supplier, anticipate rebate
- Ad hoc committee for Healthcare Consortium 3 potential plans have been formulated for analysis
- Cemetery Committee records need updating, and someone should walk the cemetery when weather permits to match physical monuments with written records.
