Some updates for Lakeshore Property Owners:

In answer to questions regarding applications for financial assistance:

Regardless of what work you think you will need done, file with DEC for a Permit. (Many contractors want to know you have already done that part before they will commit to work) This permit does not cost you any money and takes just a half hour of your time. Specific Questions can be addressed with DEC at the Mobile Command Unit - the next date they are at the Marine Park is Wednesday, 7/26.

Next, no matter which application you are currently working on or access now from the housing council website, DO NOT GET FRUSTRATED if you are asked for multiple quotes & can't get them. *Fill out all parts of the form that you can answer* right away. Most important is your personal contact information, property address (be able to provide ownership information) and your estimate of damage cost if it is asked for.

Pathstone needs to get as many applications as possible so cost estimates can be figured from their (Housing Council/Pathstone) perspective. Once they review the applications they will be back in contact with you for any additional documentation or information they need. Review the dates on the attached schedule. Representatives from Pathstone will be at the Marine Park (for specific hours as listed) on the same days that the Mobile Command Unit will be there. You will also be able to turn in your application at this site. The next date is Wednesday, July 26<sup>th</sup>, Route 98, Kent (Point Breeze Road)

Regarding your Questions on Contractors – Please keep in mind, if a Contractor is not returning your call or answering their phone – they are most likely filled to their capacity with work and cannot assist you at this time. Director Banker and I have had conversations with both the Regional & State levels of Emergency Management, Army Corps of Engineers, NYS Disaster Assessment people as recent as this morning. None of these agencies can "recommend" a list of contractors. *IF* a Federal Disaster is declared, this is when out-of-area contractors come in to the area looking for work.

What you can do now is research (Google or BING Search for example) for Breakwall Repair/Contractors from out of the area. Finger Lakes, Ohio/Lake Erie Contractors, etc.

So bottom line, please be sure to get your Permit application filed with DEC then get your Financial Assistance paperwork completed with the Housing Council/Pathstone so you can turn it in directly to Pathstone at the Marine Park next Wednesday or one of the other dates listed for August.

Another reminder, please pass on this information to anyone you might know that does not have access to internet / e-mail.
