The Hunt Library Trust is coming due, and can be reinvested to earn higher interest rates.

EFC is holding a program in Buffalo about funding opportunities to assist in water infrastructure. Supervisor Gaesser will be attending.

Orleans County Representative – Ken Rush

Towns will receive their portions of sales tax this year. The State overpaid the sales tax to the County, so it will not be sending further payments.

The county has had to borrow \$1.6 million to keep the nursing home running. Promised state aid has not yet been received. The nursing home may be sold. Visiting nurse services have been decreased.

Budget work continues. There will be a tax rate increase.

Councilman Pritchard asked if the overpayment of sales tax will be set aside. Legislator Rush did not know.

Legislator Rush stated that the cost of community college to the county is now over \$1 million annually. Students pay one third, the county pays one third, and the federal government pays one third of the tuition costs of community colleges.

Planning Board – P. Gray, Chair - training of planning members is progressing well; the Akey application for variances has been approved, with stipulations listed; the moratorium work is ongoing

Zoning Board – K. Banker, Chair – no report

Department Heads

Assessor – G. Massey – has met with the Supervisor – 7 residents filed small claims cases against the town concerning the reassessment – 6 of those cases resulted in some reduction of the assessments. The assessors of Orleans County and the Director of Real Property Services will meet to review the process. The net effect is not significant, but this may set a negative precedent.

Code Enforcement – L. Gursslin – no report

Highway - W. Kruger – the highway department does much more than just mow the cemeteries. There is trimming, repair, and general maintenance. They will appreciate any volunteer help in Fall clean-up. The town has provided the fill dirt for the gazebo project.

The work on Woodchuck Alley and Banner Beach Road is nearly done. The state inspections went well. New road signs are to be placed by year end.

Drainage issues on Kenmor will be addressed.

Whereas, the administrative aspects of dog licensing are being moved from the state level to the local level of government as signed into existence by Governor Patterson on June 22, 2010, and,

Whereas, a local law is necessary to provide for the licensing and identification of dogs in the Town of Kendall by establishing local license types and new fee structures as a result of the State of New York's dissolved interest in dog licensing, except for administering the animal population control fees,

Now, therefore, be it RESOLVED, that the Kendall Town Board does introduce Local Law 1 of the year 2010 as attached for consideration by the Town Board and to allow for public input, and further, that the Town Clerk is authorized to place a Legal Notice for a Public Hearing to consider adoption of this law, to be held on November 16, 2010 at 7:00 p.m., and to make the text of this local law available at the Kendall Town Clerk's Office for public inspection, and posted on the town website for public inspection.
