- Budget Meetings are nearly complete.

- Small Cities Grant Administration Meeting October 26, 2007 at 10:00 am. in Batavia. Supervisor Vick will be attending, and invited the Councilmen to join him.

APPROVAL OF MINUTES

Councilman Scroger made motion to approve the minutes of September 13, 2007 – Regular Town Board Meeting and September 27, 2007 – Recessed Town Board Meeting, as corrected, seconded by Councilman Gaesser. All ayes, minutes approved.

PUBLIC PARTICIPATION

Supervisor Vick introduced Bob Hart, Chairman of the Bicentennial Committee.

Mr. Hart reported that there have been two meetings of the Bicentennial Committee. He highlighted that a garden club has been started in Kendall, which has grown to nearly 25 members. This is a step toward building community spirit and influencing residents to improve the appearance of the community. Laura Partyka has offered to donate hanging baskets and flowers to spruce up downtown. The barn block quilt tour project is attracting people to Kendall. A quilt donated by the Pieceful Shores Quilting Guild has raised a substantial amount of money for the Bicentennial Fund. The committee is planning to arrange interviews with some of the Town's long-time residents. Mr. Hart feels he has not received positive response from the Town Board, and would like to see a community clean-up. Councilman Schuth pointed out that the Boy Scouts do have annual clean-ups; the specific areas chosen with input from the Highway Department. Mr. Hart responded that he never knew that, and assumes that others may also not know, and that it should be publicized better. Councilman Pritchard stated that it is announced through Lions' Club, and communicated through scout troops. Mr. Hart suggested that it be put onto the Town Hall's outside message board. The school may be involved in preparations and projects for the Bicentennial; perhaps making the local history component of the Bicentennial part of the school curriculum. The older homes in Kendall may be included in a home tour. The Bicentennial Committee is encouraging anyone with interest in joining them to contact Mr. Hart or Mr. Gillman. Mr. Hart wants response from the Town Board, and perhaps direction. Supervisor Vick responded that an alternate for Councilman Schuth will be set in place, so that a council member can attend the committee meetings. The money budgeted for clean-up is used to collect tires and other large refuse. The Highway Department is under budgetary constraints, and must put essentials first. The possibility of vandalism with the placing of flower barrels or baskets, and the possible expenses due to that vandalism has to be a consideration. Mr. Hart wants the Town Board to be involved, and so will personally attend Town Board Meetings to update them. Supervisor Vick thanked Mr. Hart.

Supervisor Vick called for any other public participation:

Lisa Stenshorn, Kendall Road, - asked what the term "succession planning" on the meeting agendas means. Supervisor Vick answered that it refers to a concerted effort to afford a back-up plan for key areas and offices.

Resolution 116-1007 Authorizing Code Enforcement Officer to Enforce Disposal of Debris and Removal of Unsafe Structures for Certain Properties

Pursuant to Sections 3 & 4 of Local Law #1 of 1982, the Code Enforcement Officer is hereby authorized and instructed to order and serve notice on the owners of the following properties, which have been destroyed by fire or abandoned or otherwise found to be in non-compliance or are deemed dangerous to the public welfare, to separate and dispose of debris and bury and cover foundations and basements to secure the sites as ordered:

819 Monroe-Orleans Countyline Road (Gary Sigler)

Further that such notice shall be served prior to October 30, 2007 and will include provision (15 days notice) for hearings in opposition to the order before the Town Board on November 15, 2007 at the Kendall Town Hall at 7:30 PM., and...

Further that the intent is for compliance with such order to occur on or before December 15, 2007 if the hearing is attended or 30 days after notice of default served no later than December 18, 2007 if the owner does not appear at the hearing, and...

Further that the intent, if there is non compliance, is that the Town of Kendall will demolish and remove the offending structures and debris on or after January 21, 2008 or on or after 60 days after notice of default with all charges incurred to be assessed against the land and levied and collected as provided for under Town Law, and further...

That it is the intent to employ the provisions of Section 9 of Local Law #1 of 1982 if it is determined, at

any point in time that the condition of these properties rises to the level of presenting a clear and imminent danger to the life, safety or health of any person or property.

The motion was seconded by Councilman Schuth.

Supervisor Vick interjected that this is the 8th property which has had to be addressed at this level. The process is slow and expensive, and priority must be given to those posing dangers to the public.

It is hereby resolved to authorize the Supervisor to contract with LaBella Associates, P.C. to provide:

Phase 1. Review of Conceptual Design at \$3,000,

Phase 2. Base Mapping at \$7,000, and

Phase3. Environmental Reviews including completion of SEQR at \$3500 for advancement of the Capital Project to construct the infrastructure for Water District 6, and...

Further, that this action is as previously committed to by Kendall Town Board Resolution 62-307.

The motion was seconded by Councilman Scroger.

Councilman Scroger asked Supervisor Vick to give a review of this funding. Supervisor Vick explained that the Board identified this district (the 40 residents of Petersmith Road) as the most obvious opportunity to achieve funding. Previously, there have been loans to fund these water districts; this is a \$400,000 outright grant. Serial Bonds will cover the remaining \$120,000. Kendall's Highway Department has the

skills necessary to install the lines. The first application for the grant was denied; the second has been approved.

There is funding available for State-mandated court facility improvements, and that makes this an opportune time to achieve other building improvements as well.
