### REGULAR MEETING, KENDALL TOWN BOARD - MARCH 10, 2005

The Supervisor called the meeting of March 10, 2005 to order at 7:28 PM and the Pledge of Allegiance was led.

#### **PUBLIC PARTICIPATION:**

Public Present: Colin Zimmerman, Mike Lester, Allen Lofthouse, Beverly Lofthouse, Lisa Skrypnik, Catherine DiBella

Colin Zimmerman – 164799 Roosevelt Highway

Was very upset that the Town of Kendall sold the Civil War Artillery Cannon from the Greenwood Cemetery. Some of his points included the resolution adopted in October 2004 indicated "refurbish" when the Town sold it. Questioned the Town Board's intent in the resolution. Questioned the definition of refurbish. Colin indicated that dictionary definition for refurbish does not have anything to do with sell. Supervisor Becker stated their major concern was that the cannon be stolen once the public found out the value of it. Supervisor Becker stated that part of refurbishment was the installation of the replica barrel and cleaning the carriage. Colin felt they had no authority to sell based on the resolution adopted. If concerned about it stolen then why not insure it, or secure it and not sell it. Asked if the Town Board requested any help to secure the cannon. Questioned if the Town ever requested it to be insured. If money was a concern, then asked if any service agencies were asked to help maintain the cemetery. The Town was not concerned about the money, the funds from the sale of the cannon will be put in a Trust Fund for the Cemetery and interest from the Trust fund will help operate the Cemetery, stated Supervisor Becker. The Cemetery is self sustaining. Colin asked who the prominent people were that Supervisor Becker spoke with. Supervisor Becker did not provide names for fear of harassment towards those individuals. Did the Town Board research the museum?, asked Colin. Colin asked if any officials have gone to this museum? Supervisor Becker stated he researched it through other municipalities and looked at museum's charter. Colin asked if looked into the background of the person whom purchased the cannon. Colin claims that the man who purchased it is a Civil War Artillery Broker. Colin was in contact with the Orleans Veterans Association, US Government in Washington, the United States Army Material Command, Joints of Veterans Council and this man is going all over the country buying up cannons and would have offered four times more than what was given to the Town of Kendall. Colin Zimmerman calls this desecration and quoted the Webster's Dictionary definition.

Colin Zimmerman requested the board to make a resolution not to sell the Memorial Rock that he gifted the Town of Kendall in 1995 that he donated to the Town of Kendall. Supervisor Becker would not take this under consideration. Colin stated that this memorial is worth 10,000.00.

Mike Lester – Assistant Scout Leader for Troop 94

Feels that this should be undone. Highlights of the Memorial Day events is to see the cannon. Fake is a fraud and that is wrong. It is a true artillery piece and it should be left alone. Feels the sale is a terrible injustice. Don't care if it fires or it just sits there people admire these artillery pieces. Not only did the Town of Kendall be duped but the residents have been duped in the Town of Kendall. E-bay would put 60 to 70 thousand dollar value on this which would get you a trust fund

Colin Zimmerman asked if any Council members have opinions on this. Councilwoman Robinson indicated research was done on e-bay and could only find canons that are real things that were around 3 to 4 thousand dollars. Per Mike and Colin those are canons, this sold canon was a true artillery piece, and there is a difference. Desecration comes back to mind. Councilwoman Robinson stated she felt we were doing a good thing.

Supervisor Becker stated that the money went into a Trust Fund. The Greenwood Cemetery is self sustaining. It was not sold for the money to operate the Cemetery.

Colin Zimmerman stated that museums never buy items; they want you to give it to them. Rochester and Buffalo Museums usually want items donated, same with the Smithsonian. Colin contacted the US Army Material Command of which has a file on this gentleman very thick. They have had agencies after him and there are no laws to stop this man from doing what he is doing. A Congressman in Rhode Island Colin has been trying to talk with and will try to put a bill through to stop this. People in Washington are working to cataloging all these cannons and equipment to try to preserve them. There are so many rules and regulations for these pieces to be sure they are not desecrated. Colin has done all this research in two days and feels that the Town Board did not do their research.
