## RESOLUTION 66-0618 COMMUNITY DEVELOPMENT BLOCK GRANT: IMMINENT THREAT, PUBLIC INFRASTRUCTURE & MITIGATION 2017 of LAKE ONTARIO FLOODING

WHEREAS, the Town of Kendall submitted an application under the 2017 Imminent Threat Program for Community Development Block Grant (CDBG) funding for the Public Infrastructure Repair and Mitigation 2017 Lake Ontario Flooding Project; and

WHEREAS, the Town's application in the amount of \$397,950 has been approved by the NYS Office of Community Renewal, so

BE IT RESOLVED, that the Town Board of the Town of Kendall hereby accepts the CDBG grant award and authorizes the Supervisor to execute the grant agreement and provide additional documentation to the NYS OCR as required for the project.

BE IT FURTHER RESOLVED, that the Town Board hereby authorizes the Supervisor to solicit proposals, consistent with CDBG procurement requirements, from qualified firms to provide administrative services to assist the Town to implement the project.
