## RESOLUTIONS

Councilwoman Szozda made the following motion, seconded by Councilwoman Flow:

## RESOLUTION 75-0718 TOWN OF KENDALL – WATER DISTRICT NO. 9 AUTHORIZATION TO ADVERTISE FOR BIDS

Whereas, the Town of Kendall has received approval for a grant award in the amount of \$150,000 under the State Assistance to Municipalities (SAM) program for the construction of the water system improvements for the Town of Kendall Water District No. 9; and

Whereas, the Town has committed local funds in the amount of \$65,000 to complete the project; and

Whereas, the Town has completed the administrative requirements for the grant award and is expecting a Grant Disbursement Agreement to be issued by the Dormitory Authority of the State of New York (DASNY).

Be it resolved that the Town Supervisor is hereby authorized to advertise for and solicit bids for the construction of the water system improvements.

Be it further resolved that the Town reserves the right to defer the award of the contract until the Grant Disbursement Agreement has been executed.

Supervisor Cammarata called for a vote, resulting in all ayes, and declared the motion carried.

Councilwoman Flow made the following motion, seconded by Councilwoman Szozda:

## RESOLUTION 76-0718 TO UNDERTAKE AND IMPLEMENT A REASSESSMENT OF THE TOWN OF KENDALL IN 2019

WHEREAS Section 305 of the New York State Real Property Tax Law mandates uniform and equitable assessments; and...

WHEREAS computer-assisted mass appraisal systems, technical advice and financial assistance are available by cooperative agreement with the New York State Office of Real Property services and the Orleans County Real Property Tax Service Agency; and

WHEREAS the last town-wide reassessment of our real property took place in 2016; and

WHEREAS, the Town Board is convinced that a reassessment is necessary to comply with Section 305 of the New York State Real Property Tax Law;

Now, therefore, be it RESOLVED by the Town Board of Kendall, New York as follows:

That the assessor of the Town of Kendall is hereby authorized to undertake and implement a reassessment for the 2019 assessment roll;

That the Kendall Town Board does hereby agree, in conjunction with the New York State Office of Real Property Services, and the Orleans County Real Property Tax Services Agency to support the town's assessment staff in this reassessment; and,

That the Kendall Town Board and the Assessor are authorized to enter into any agreements necessary to achieve this purpose. Any agreements resulting in expenditure by the Town of Kendall must first be approved by the Town Board. Any agreement with a private contractor to provide services for this reassessment shall be entered into only upon review by the Attorney for the Town, the Assessor, and a representative from the Office of Real Property Services.

Supervisor Cammarata called for a vote, resulting in all ayes, and declared the motion carried.

Councilman Newell made the following motion, seconded by Councilwoman Flow:

## **RESOLUTION 77-0718 BUDGET TRANSFER**

Be it resolved to transfer \$250.00 from General Account A8930.4 Research to General Account A8010.4 Zoning Contractual.

# **RESOLUTION 78-0718 CDBG GRANT AWARD FOR ADMINISTRATIVE SERVICE TO LABELLA PC**

Be it resolved that the Kendall Town Board authorizes Supervisor Cammarata to sign the 2017 CDBG Grant Award for Public Infrastructure Repair Project agreement for administrative services to LaBella PC, 300 State Street, Suite 201, Rochester, NY 14614. At a cost not to exceed \$18,000.00. The agreement is subject to review of form and content by Attorney Meier.

Councilwoman Szozda made the following motion, seconded by Councilwoman Flow:

# **RESOLUTION 79-0718 CONSERVATION EASEMENT BETWEEN ONTARIO LAKESIDE RESORT, NY LLC AND THAT TOWN OF KENDALL**

BE it Resolved, that the Kendall Town Board authorizes Supervisor Cammarata to sign a Conservation Easement between the Town of Kendall (Grantee) and Ontario Lakeside Resort, New York LLC having an office c/o Midland Management 758 South Avenue, Rochester, N.Y. 14620 (Grantor).

The Kendall Highway Superintendent and the Attorney for the Town have reviewed and approved this agreement.

Discussion: Supervisor Cammarata said this is the wetlands of Troutburg. When the road was changed during the development of Troutburg, it was required that wetlands be "replaced". The DEC requires an easement. Mr. Howitt, the current owner of Troutburg asked the town to do this. Attorney Meier said it is a standard request.

Supervisor Cammarata called for a vote, resulting in all ayes, and declared the motion carried.

Councilwoman Flow made the following motion, which was seconded by Councilwoman Szozda:

## **RESOLUTION 80-0718 AUTHORIZING THE TOWN SUPERVISOR TO SOLICIT BIDS FOR TOWN HALL AND HIGHWAY BUILDING IMPROVEMENTS**

Whereas, the Town of Kendall has received approval for a State and Municipal Facilities Program (SAM) grant in the amount of \$75,000 for replacement of the roof and doors at the Town Hall and the roof at the Town Highway Building, and

Whereas, the Dormitory Authority of the State of New York (DASNY), the funding agency, has approved the scope of the project and budget for the project, and

Whereas, specifications for these improvements have been completed and approved by the Town Board,

Be it RESOLVED that the Town Supervisor is hereby authorized to solicit bids for the replacement of the roof on the Town Hall with a metal roof, new doors on the Town Hall, and roof replacement at the Town Highway garage.

Discussion: Councilwoman Flow asked if the new doors would be handicapped accessible. Supervisor Cammarata said, "Right. It's only the front doors." The ads will run this Sunday.

Councilman Newell made a motion to pay the claims as presented on Abstract 7. Motion was seconded by Councilwoman Flow; all ayes. Motion carried.
