RESOLUTIONS

Councilman Newell made the following motion, seconded by Councilwoman Flow:

RESOLUTION 43-0120 AUTHORIZING PURCHASE OF LOADER AND LOADER ATTACHMENTS

WHEREAS, the Town Board, upon consult with the Highway Superintendent, wishes to purchase a New Holland C237 Skid Steer Loader, and a Brodco C8678 High Flow 78" Rotary Motor Attachment, at a total net cost of \$64,579.50 for both items, from the New York State Contract PC67087, and

WHEREAS, the Town Board has determined that such purchase is for appropriate highway-related purposes and is in the public interest, so

NOW, BE IT RESOLVED that the Town Board hereby authorizes the purchase of the following highway equipment:

- 1. One New Holland C237 Skid Steer Loader, and
- 2. One Brodco C8678 High Flow 78" Rotary Motor Attachment, at a cost not to exceed \$64,579.50.

BE IT FURTHER RESOLVED, that the funds to purchase the above equipment shall be drawn on account.

Supervisor Cammarata called for a vote, resulting in all ayes, and declared the motion passed.

Councilman Martin made the following motion, seconded by Councilwoman Szozda:

RESOLUTION 44-0120 REQUESTING THE TRANSFER OF 1.68 ACRES OF LAND FROM THE NEW YORK STATE PARKS, RECREATION AND HISTORIC PRESERVATION COMMISSION FOR THE REPAIR OF THE THOMPSON DRIVE CUL DE SAC.

WHEREAS, Thompson Drive in the Town of Kendall is dependent on the cul de sac at its end, which is located on land belonging to NYS Parks, and

WHEREAS, said cul de sac on Thompson Drive is severely damaged by the erosion which occurred during the 2017 Lake Ontario high water emergency and is in need of repair, and so the Town of Kendall is requesting the transfer of 1.68 acres of land as described below, from the New York State Parks and Historic Preservation, Genesee Region, for road purposes:

ALL THAT TRACT OR PARCEL OF LAND, situate in the Town of Kendall, County of Orleans, and New York State, being part of Lot 1, Township 4, of the 100,000 Acre Connecticut Tract, as shown on a map of Lakeside Beach State Park, Lake Ontario State Parkway, prepared by John E. McIntosh, L.S., dated October 18, 1963, drawing A-3009, Sheet 9 of 14, bounded and described as follows:

BEGINNING at the southwest corner of sublot no. 16 of the Transit Site subdivision at the easterly bounds of Thompson Drive;

THENCE S 02°-26' -44"East a distance of 50.00 feet of said Thompson Drive;

THENCE S 87°-33'-16" West a distance of 198.00 feet to a point;

THENCE N 84°-57'-07" West a distance of 402.98 feet to a point;

THENCE N 00°-16'-58" West a distance of 89± feet to the top of bank of Lake Ontario;

THENCE easterly along the top of bank of Lake Ontario a distance of $601.6 \pm \text{feet to a point}$;

THENCE S 02° -26'-44" East a distance of $117\pm$ feet to the point or place of beginning Containing $1.68\pm$ acres of land.

Therefore, be it Resolved, to authorize Supervisor Cammarata to pursue the acquisition of this property.

DISCUSSION: This is included in the REDI projects. At Councilman Newell's request, the description was checked against the original. This was reviewed with the NYS Parks Department. All was in order.

Supervisor Cammarata called for a vote, resulting in all ayes, and declared the motion passed.

Councilwoman Szozda made the following motion, seconded by Councilman Martin:

RESOLUTION 45-0120 AUTHORIZING AGREEMENT WITH FISCAL ADVISORS FOR WATER DISTRICT TEN

Be it Resolved to authorize Supervisor Cammarata to sign a service agreement with Fiscal Advisors & Marketing, to provide services relating to the issuance of Bond Anticipation Notes for Water District Ten, West Kendall Road, at a cost of \$2,430.

Supervisor Cammarata called for a vote, resulting in all ayes, and declared the motion passed.
