Whereas, the Town of Kendall advertised bids for Water District No 10 - W. Kendall Road Contract 1 – Water Main Installation and Boring, and

Whereas, the Advertisement for the bids appeared in the Town's official newspaper on June 28, 2020, and

Whereas, bids were received on July 14, 2020 at the time and location indicated in the Advertisement for Bids and were publicly read out loud, and

Whereas, the Town's consulting Engineer, LaBella Associates, DPC has reviewed the bids and determine the apparent low bidder was Randsco Pipeline Inc. with a base bid of \$109,400.00, and

Whereas, the bid submitted was complete and

Whereas, the amount of the bid was within the allowable budget for such work, and

Therefore be it resolved that the Town Board of the Town of Kendall herby resolves the following:

- Award the contract for the base bid for Town of Kendall Water District No 10 W. Kendall Road Contract 1 – Water Main Installation and Boring to Randsco Pipeline Inc., in the amount of \$109,400.00 subject to approval from Rural Development of the award and receiving the insurance certificates from the Contractor as outlined in the Contract Documents.
- 2. Retain bid securities from all bidders until the contract has been awarded, and
- 3. Return the checks for the purchase of the Contract Documents to those submitting bids as provided for in the Special Conditions.

Whereas, the Ad appeared in the Town's official newspaper on June 28, 2020, and

Whereas, bids were received on July 14, 2020 at the time and location indicated in the Advertisement for Bids and read out loud, and

Whereas, the Town Engineer, LaBella Associates, DPC has reviewed the bids and determine the apparent low bidder was T. Mina Supply East, Inc. with a bid of \$116,323.70, and

Whereas, the amount of the bid was lower than the amount budgeted for such materials, and

Whereas, the bid was complete, and

Whereas, said form was executed following the bid,

Now and therefore the Town Board of the Town of Kendall resolves to:

- Award the contract for material supply for Town of Kendall Water District No. 10 W. Kendall Road Contract 2A – Water Main Materials to T. Mina Supply East, Inc. in the amount of \$116,323.70 subject to approval from Rural Development of the award and receiving the insurance certificates from the Contractor as outlined in the Contract Documents.
- 2. Retain bid securities from all bidders until the contract was been awarded, and
- 3. Return the checks for the purchase of the Contract Documents to those submitting bids as provided for in the Special Conditions.

Whereas the Town of Kendall and the Town of Hamlin Have agreed to complete "Owner Construction" for Water District No. 10 – W. Kendall Road Contract 2B – Water Main Installation, and

Whereas, the Town of Hamlin has submitted unit prices for the construction of said District, and

Whereas, the Town of Kendall is to provide all materials for installation, and

Whereas, the Town Engineer, LaBella Associates DPC, has reviewed the units prices submitted and recommends award of the contract to the Town of Hamlin, so

Now and therefore the Town Board of the Town of Kendall resolves to award the contract to the Town of Hamlin in the amount of two hundred twenty-nine thousand, one hundred ninety-nine dollars and no cents (\$229,199.00).

Clean Energy Community – Councilman Newell is investigating

Sewer District being formed – Monroe County has sent its out-of-district-user form. It will be reviewed by the Town Board and the Attorney for the Town.

Four private lakefront roads versus Modern Recycling issue of insufficient area for turn arounds – being addressed.

Bald Eagle Drive's last resident is willing to allow a turnaround for the garbage trucks on his property, which will be sufficient.

Norway Heights – a title search is being conducted to determine if the Town has a right of easement or ownership at the end of that private road in which to build an adequate turnaround. The current property owner believes he has ownership of the affected land, and does not want to

lose property to provide a turnaround. The other two roads were not discussed.

Legalities will be discussed with the Attorney for the Town. Supervisor Cammarata expressed his opinion that this is a situation for the County to help negotiate.

The larger trucks now used in the waste/recycling program are cost effective, but more difficult to maneuver, which has brought up the issue. Councilwoman Szozda suggested the affected roads not be charged the fee on the property tax bill, and instead contract with a private disposal company. Supervisor Cammarata suggested the county or the disposal company could purchase a smaller truck to be used only on the affected private roads. He is hopeful there will be cooperation of the residents on those private roads and the solution can be simple.

With no further business being brought forth, a motion for recess until August 4, 2020 at 7:00 p.m. was put forward by Supervisor Cammarata, and was seconded by Councilwoman Flow. All ayes. Meeting recessed at 8:16 p.m.
