CORRESPONDENCE

MCDES – re. sewer

The flow required for the proposed waste water treatment system on the lakefront can be handled by the Monroe County Department of Environmental Services, through the Hamlin Beach State Park. This is positive news. Kendall would be the only municipality outside of Monroe County to be hooked into its system.

PUBLIC COMMENT

Debra Kluth, Town Justice – The company currently used by the court is G4 Secure Solutions. It is asking to renegotiate its contract. Judge Kluth has some reservations about the service, and also cannot find a current contract. There are no specific requirements for court security. Many towns use off duty or retired law enforcement personnel. There is a company called COPS which provides security for several courts in Orleans County. Judge Kluth is asking the Town Board for guidance and direction as to how to provide security on DA nights. The board asked for a copy of the current contract, if possible, and will make a determination based on the judges' recommendations.
