Supervisor Cammarata called the meeting to order at 7:00 p.m., and led the Pledge of Allegiance.

Councilwoman Flow suggested accepting the minutes of the October 20, 2020 Public Hearing and Regular Meeting. All were in agreement.

### SUPERVISOR'S COMMENTS

Closing on Water District Eight financing is next week.

Water District Ten is near completion.

Sewer project – Intermunicipal agreements are being forged with Monroe County and the Town of Hamlin. Fall 2021 is a possible start date.

2021 Budget has been delivered to the Real Property Director and the Clerk of the Legislature.

The county health department has delivered more face masks and hand sanitizers. There may be further restrictions as the number of COVID cases increases.

### PUBLIC COMMENT

Truda Slocum asked the number of students from Kendall who go to community colleges.

Supervisor Cammarata said the cost of these colleges is split with one third paid by the student, one third is paid by the State, and one third will be shared by the county and town, as when the county reaches its cap amount, the town will pay the difference. There was not an answer given as to how many students from Kendall are involved.

Supervisor Cammarata called for a vote, which resulted in all ayes, and declared the motion carried.

Councilwoman Szozda made the following motion, which was seconded by Councilman Martin:

# RESOLUTION 107-1120 TOWN OF KENDALL REDI WASTEWATER INFRASTRUCTURE PHASE 2 – SEQR & DISTRICT FORMATION.

Be it resolved that the Kendall Town Board authorizes Supervisor Cammarata to sign a proposal for services with La Bella Associates for professional engineering services for the Town of Kendall REDI Wastewater Infrastructure- Phase 2. The services include: Environmental Review (SEQR) at a cost of \$9,500.00, a Map Plan & Report at a cost of \$5,800.00, and preparation of a District Formation and Inter-Municipal Agreement at a cost of \$4,500. The total is not to exceed \$19,800.00.

Discussion: Supervisor Cammarata said this is so expensive because the magnitude of the project. The long version is necessary.

Supervisor Cammarata called for a vote, which resulted in all ayes, and declared the motion carried.

Councilwoman Flow made the following motion, which was seconded by Councilman Newell:

# RESOLUTION 108-1120 NEGATIVE DECLARATION OF ENVIRONMENTAL SIGNFICANCE FOR REDI PROJECT NUMBER 32, THOMPSON DRIVE TURN AROUND.

Be it resolved the Town Board of the Town of Kendall declares that it will serve as the Lead Agency for this Thompson Drive Turn Around Project.

The Town Board has considered the Environmental Record prepared for this action, including any comments received from the Involved Agencies, and the proposed Negative Declaration.

The Town Board declares that, based upon the Environmental Record, which has been prepared, the Project will not result in any large or important impacts, and therefore, will not have a significant adverse impact on the environment. A Negative Declaration under SEQR is therefore issued for this project, and Supervisor Cammarata is hereby authorized and directed to prepare and issue on behalf of the Town, the Negative Declaration in the Part 3 of the Environmental Assessment Form.

Discussion: Councilman Martin asked if there has been communication with the neighboring resident of this project, and if there will be a means to voice any concerns. Supervisor Cammarata replied that the SEQR determination has to come first.

# RESOLUTION 111-1120 AUTHORIZING EXECUTION OF AGREEMENT TO EXPEND HIGHWAY MONEYS

WHEREAS, the Kendall Town Board and the Highway Superintendent have agreed to set aside the amount of \$ 114,500 for general repairs and \$ 156,509.07 for permanent improvements, and to undertake the specific improvements set forth in the agreement attached; and,

WHEREAS, this agreement is to be executed in furtherance of the provisions of Section 284 of the New York State Highway Law; and,

WHEREAS, the Town Board has determined that it is in the best interest of the Town to authorize the execution of the attached agreement, and,

WHEREAS, the execution of the agreement to spend Town Highway Funds for repairs and improvements to Town of Kendall roads is hereby determined not to have a significant effect on the environment, so now, therefore, be it

RESOLVED, that the Town Supervisor and Highway Superintendent be authorized to execute the attached Agreement to spend Town Highway Funds.

Supervisor Cammarata called for a vote, which resulted in all ayes, and declared the motion carried.
