RESOLUTION 112-1220 BUDGET MODIFICATION – WATER DISTRICT EIGHT

Whereas, the Town of Kendall developed the budget for the Water District Eight project based on estimates for the cost for the Net Interest Expense, and

Whereas, the actual costs for the Net Interest Expense will be more than the currently budgeted amount,

Be it resolved that the Town Board hereby authorizes an increase in the budget for the Net Interest Expense of \$2,163, from \$9,450 to \$11,613, with a corresponding decrease in the Contingency.

Discussion: This is a reimbursable amount.

Supervisor Cammarata called for a vote, which resulted in all ayes, and declared the motion carried.

Councilman Martin made the following motion, which was seconded by Councilwoman Szozda:

RESOLUTION 113-1220 BUDGET TRANSFER

Be it resolved to decrease General Account A1990.40, Contingent, by \$4,451.00, and increase the following General Accounts: A1450.40 Elections by \$2,755.00,

A1620.10 Buildings Personal Services by \$196.00, and

A1620.40 Buildings Contractual by \$1500.00.

Supervisor Cammarata called for a vote, which resulted in all ayes, and declared the motion carried.

Councilwoman Szozda made the following motion, which was seconded by Councilwoman Flow:

RESOLUTION 114-1220 BUDGET AMENDMENT

Be it resolved to increase Highway Revenue Account DA3502.00 by \$35,000.00, and increase Highway Expense Account DA5110.40 Maintenance of Streets Contractual by \$24,000.00 and Highway Expense Account DA5110.10 Maintenance of Streets Personal Services by \$11,000.00.

Supervisor Cammarata called for a vote, which resulted in all ayes, and declared the motion carried.

Councilwoman Flow made the following motion, which was seconded by Councilman Martin:

RESOLUTION 115-1220 APPROVING OUT OF DISTRICT USER AGREEMENT BETWEEN TOWN OF KENDALL RESIDENT AND THE TOWN OF CARLTON

RESOLVED, that pursuant to the provisions of §198(3)(b) of the Town Law of the State of New York, the Kendall Town Board hereby consents to the Town of Carlton entering into an outside user agreement with the following owner of real property situate on the south side of Roosevelt Highway, which premises is contiguous to, or within 500 feet of, the boundaries of a Carlton Water District, providing for the Town of Carlton to supply public water to said the property through the Town of Carlton water distribution system:

Owner: Matthew and Jillian Kludt

Property Address: 15700 Roosevelt Highway

Tax Account No.: 343000 31.-1-22.111

FURTHER RESOLVED, that the property owner shall acknowledge in such agreement that if the Town of Kendall establishes a water district in the future which includes the owner's property, the owner will be deemed to benefit from inclusion in that water district and they will be assessed a bond repayment charge.
