PUBLIC COMMENT

Bob McGregor, 1909 West Kendall Road – asked questions about the water districts. Supervisor Cammarata said there are 10 districts in the town, nine of which are supplied and billed by Monroe County Water Authority.

Sally and Jerry Bropst, 17106 Creek Road – reiterated that they do not have cable available at their home, asked why they were "skipped" when the original cable agreement was made, and stated that it puts them at a disadvantage personally and in trying to rent an available apartment they have.

Supervisor Cammarata said there are nine households in town which do not have cable available. He said he has previously stated to Mr. and Mrs. Bropst that this is not a Town issue. There may be financial help available from the federal government for low to medium income families due to new legislation. There is also new legislation which will help with broadband being more universally available. He gave a name of a person at Spectrum who may aid them.

Mrs. Bropst asked about a house near her, on Creek Road, which is mess to the point of being a hazard.

CEO Hennekey said that property was recently sold at auction, and clean-up has begun.

Be it hereby resolved that the Kendall Town Board authorizes Supervisor Cammarata to sign a professional services agreement with LaBella Associates, 300 State Street, Suite 201, Rochester, New York, in the amount of \$1,094,800.00 (one million ninety four thousand eight hundred dollars) for LaBella Associates, Project Number 2200455, for Planning, Designing, and Inspections, of REDI Project 62 Wastewater Infrastructure, for which the Town of Kendall has been awarded a grant of \$9,053,000.00.

Security will provide armed security services beginning May 2021 at the Kendall Town Hall, 1873 Kendall Road, Kendall, New York 14476. Each shift will consist of four (4) consecutive hours at an hourly rate of \$39.00 per hour.
