Public Culverts are almost completed with exception of the Thompson Road culvert.

Thompson Road Park: Waiting on DASNY's approval to proceed with purchases for benches, grills, and tables. Very proud of the work Warren and our highway people regarding this park.

Sewers: Monroe County granted us approval to pump into their plant. This is a major step forward. Waiting on NYS Parks approval for funding assistance and other grant funding, which is necessary for us to proceed forward.

PUBLIC COMMENT

David Bentley, Norway Road – as spokesman for STROUT – Short Term Rental Owners United Together, which has hired an attorney to protect the owners' rights to use their properties as they desire, asked if the public hearing regarding the proposed laws regulating short term rentals could be postponed for a number of weeks to enable negotiations prior to the laws' passage. The effort is to avoid legal fees for both parties, and to amicably come to reasonable regulations, and avoid litigation against the Town.
