SUPERVISOR'S REMARKS SUPERVISOR'S COMMENTS:

"The independent auditor's called and confirmed that they will be at the Kendall Town Hall on April 25 & 26th if necessary, for our annual audit. They will also do the annual audit for our justice department in the coming months.

W D #11: Since the USDA has not updated their MHI thresholds to date and do not expect it to until October of 2023. I contacted USDA for a status. If we applied for a market loan the interest rate would be 3.75 until June of 2023 and it is unknown beyond that date. So even if the interest was 4% and we did not have any grant funding the annual cost per benefit user would exceed the State Comptrollers threshold.

Trash: I attended a meeting regarding the new contract between Orleans County and Modern Disposal. I think we are in a much better position than the towns of Carlton and Yates. Another meeting is being established to discuss various options.

Meeting Date Change: It has been our policy to support the Kendall School District when ever possible. They did request to use the Kendall Town Hall on May 16th for their annual election. Thus to accommodate the school's request we will change our scheduled Town Board Meeting from May 16 to May 18th, 2023, at 7 pm at the Kendall Town Hall."

TO COMMENT ON LOCAL LAW 5, known as <u>A LOCAL LAW TO ADOPT A BRUSH AND</u> WEEDS LAW OF THE TOWN OF KENDALL

Neither the supervisor nor board members offered any introduction or comment regarding this proposed law.

Truda Slocum – submitted a letter (copy attached) in opposition to this law, and read a statement from her husband, who was unable to attend and participate due to a lack of accommodations for deaf citizens.

Jason Hardenbrook – spoke in opposition to this proposed law. Those who live in the woods will not mow their property to these standards because it would destroy wildlife habitat and defeat the purpose of choosing to live where they do.

Mr. McGregor asked the Town Board what the desired purpose of proposed Local Law 5 is. Supervisor Cammarata said he would not engage in dialogue, but would answer that question after the meeting.

No one else answered the call to comment.

The Town Board agreed to take the comments offered under consideration.

PUBLIC COMMENT

Eric Maxon – asked the supervisor why he would not answer Mr. McGregor's simple question. Others may have the same question, and it could be answered on record to avoid misunderstandings.

Supervisor Cammarata stated he had explained his ground rules before the meeting started and was not answering questions at the public hearing.

David Bentley – said that at a work session recently, it was stated that at least three bids would be sought for installing the sewer district, and wondered if the same was done for the proposed water district eleven, or if only LaBella Engineering was considered.

Supervisor Cammarata said he heard him, and would talk to Mr. Bentley after the meeting to explain the process.

Mr. Bentley had gathered other pricing from another engineering company, and it stated lower pricing than the estimates of potential costs submitted by LaBella.

Mr. Bentley read a portion of an intermunicipal agreement, and asked if Kendall will be responsible for the costs of the Town of Hamlin sewer lines.

Supervisor Cammarata answered that the Town of Kendall users will not be responsible for any of Hamlin's costs. He encouraged Mr. Bentley to come into his office and have what he is misunderstanding explained.

Mr. Bentley asked if there was an accounting record available for the sewer project. Supervisor Cammarata said all the information is available in the Map, Plan and Report.

Mr. Bentley said he has more questions. Supervisor Cammarata said Mr. Bentley's time was done.
